

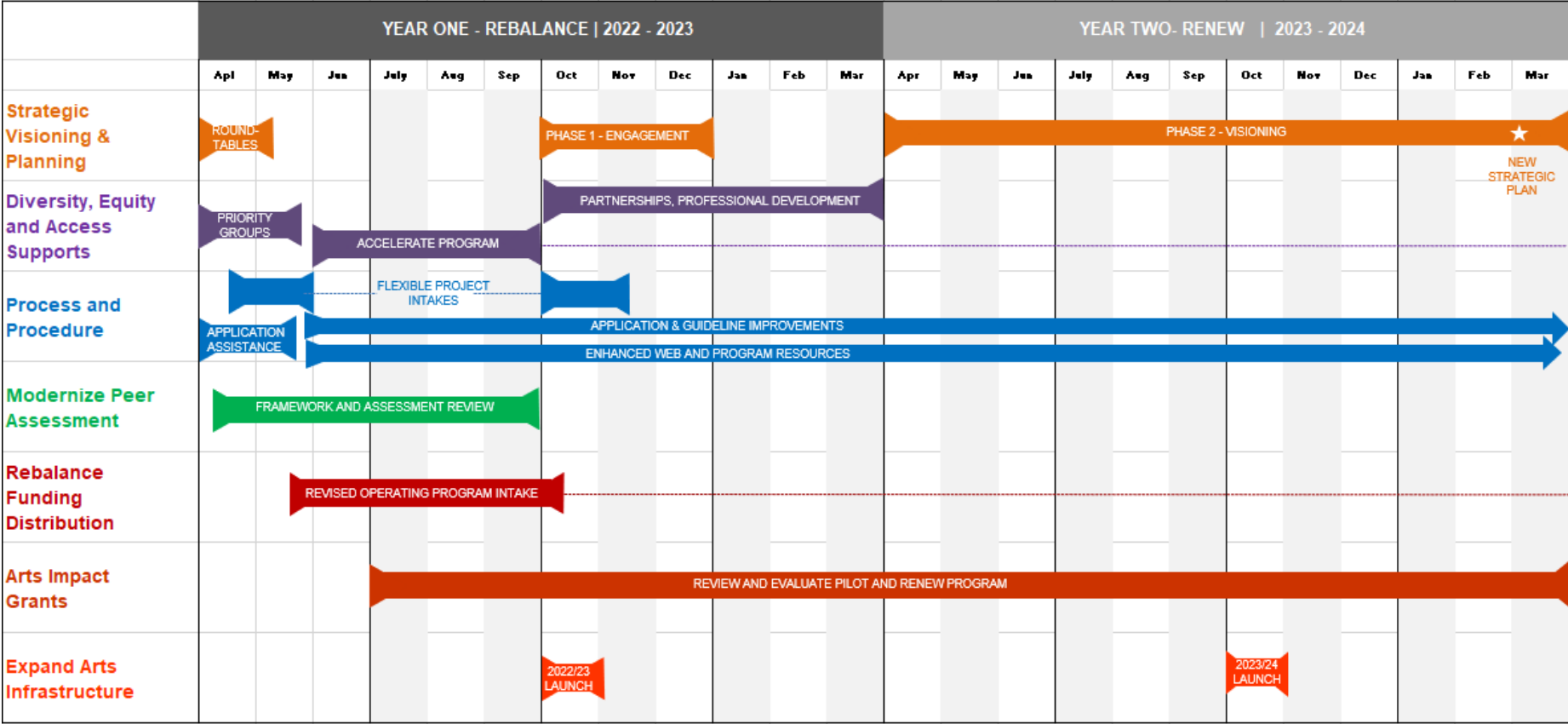
# Extending Foundations Action Plan – Activity Tracker

## Renew Strategic Visioning and Planning

### CURRENT STRATEGIC PLAN EXTENSION

- **Launch *Extending Foundations: Action Plan 2022-2024*.**
  - ✓ Announcement and community gathering with Minister Melanie Mark, Parliamentary Secretary Bob D'Eith and BC Arts Council Chair Stan Chung and Vice Chair Dana Claxton - April 2022.
- **Continue implementation of existing strategic directions.**
  - 1) *Sustainability and Creative Development*
  - 2) *Equity, Diversity and Access.*
  - 3) *Indigenous Arts and Culture*
  - 4) *Regional Arts and Community Arts*
- ✓ Complete progress evaluation on New Foundations strategic plan – April 2022.

### STRATEGIC VISION FOR 2024

- **Advance opportunities for further renewal in 2024.**
  - ✓ Virtual regional roundtables hosted by Parliamentary Secretary D'Eith and BC Arts Council – April/May 2022.
- **Continue engagement to set the stage for next round of visioning.**
  - ✓ Launch approach for next round of strategic visioning in Fall 2023.



## Establish Diversity, Equity and Access Program Supports

### TARGETED INVESTMENT IN UNDERSERVED AND EQUITY DESERVING ORGANIZATIONS

- **Create multi-year capacity building program.**
  - ✓ Open Accelerate program for equity-deserving and regional arts and cultural organizations and collectives – September 2022.
  - ✓ Accelerate program provides the first installation of \$2.5 million in funding annually over two years to 145 regional and equity deserving organizations for 2022/23 and 2023/24 – Spring 2023.
- **Provide suite of supports through partnerships and research.**
  - ✓ Introduce Equity Data Tool to better support program evaluation and research – September 2022.
  - ✓ Review and revision of Equity Data Tool – ONGOING.
  - ✓ Participation in National Research Group - ONGOING

### EQUITY SUPPORT INITIATIVES

- **Develop new partnerships for program delivery.**
- **Expand professional and organizational development activities.**
  - ✓ Develop learning pathways to support equity competencies in collaboration with community - Winter 2022/23.
  - ✓ Launch learning pathways program with Arts Service Organization partners – June 2023.
- **Create equity advisory structures to enhance voices of Indigenous and equity-deserving communities in policy, programs and processes.**
  - ✓ Implement Equity Advisory Network to inform assessment, implementation and policy – October 2022.
  - ✓ Expand and continue to develop Equity Advisory Network approach – ONGOING.
  - ☐ Introduce BC Arts Council Elder in Residence – Winter 2023/24.

- **Introduce designated priority groups policy based on existing strategic directions and identified gaps.**
  - ✓ Introduce designated priority groups policy and web page – April 2022.
  - ✓ Implement a designated priority groups questionnaire within registration profile to support eligibility and access to strategic programs and funds – September 2022.
  - ✓ Work with Equity Advisory Network and First Peoples’ Cultural Council in the development and implementation of designated priority groups policy and validation of applicants - ONGOING
  - ✓ Implement revised voluntary self-identification mechanisms to support data collection - September 2022/ONGOING.
  - ✓ Implement improvements to Designated Priority Group policy and tool based on feedback – Spring 2023.



## Implement Process and Procedure Improvements

### REDUCED BARRIERS TO FUNDING PROGRAMS

- **Streamline program intakes for flexibility and accessibility.**
  - ✓ Introduce two deadlines per year for Professional Project Assistance Programs, providing greater flexibility for timing of projects and funding – April 2022.
  - ✓ Implement new program for individual artists in performing arts – April 2022.
  - ✓ Combine Literary and Publishing project programs – April 2022.
  - ✓ Move all Professional Operating Assistance to one intake deadline for Fall 2022 – June 2022.
  - ✓ Re-introduce two year funding cycles for Operating Assistance for 2022/23 – June 2022.
  - ✓ Introduce flexible funding opportunities including sector-based activities through Arts Impact Grants – October 2022.

### INCREASED ACCESS TO SERVICES

- **Introduce application assistance funding for applicants requiring service provider**
  - ✓ Launch Application Assistance – April 2022.
  - ✓ Launch Access Support funding – April 2022.
- **Launch webinar and regional outreach series.**
  - ✓ Information session on new accessibility initiatives – May 2022.
  - ✓ Community Connections session in Prince George – October 2022; Kelowna – May 2023; Surrey – November 2023.
  - ✓ Participate in regional community convenings including: Kamloops – February 2023; Kootenays – Summer 2023; Prince Rupert – November 2023.
  - ✓ Launch topic-based webinar series – Winter 2023.
- **Enhance web resources to increase transparency and accessibility.**
  - ✓ Add accessibility resources page – April 2022.
  - ✓ Add glossary of terms – April 2022.

- **Simplify program guidelines.**
  - ✓ Modernize fields of practice groupings within Operating Assistance guidelines to streamline program offerings – June 2022.
  - ✓ Simplify and streamline Operating Assistance program guidelines – reduced to 8 pages from 13 – June 2022.
- **Reduce barriers in application process**
  - ✓ Introduce opportunities for video/oral components within project applications – April 2022.
  - ✓ Implement Accessibility Coordinator staff position(s) –ONGOING
  - ✓ Implement regionally-based Program Advisor position – ONGOING
  - ✓ Change Program Officer title to Program Advisor – April 2022.
  - ✓ Integrate plain language approach across application materials and communications. ONGOING
  - ✓ Collaborate with sector to respond to Operating Assistance survey – March 2023.
- ✓ Launch ASL resource and informational videos – April 2022.
- ✓ Launch series of recorded information sessions to be posted online – August 2022.
- ✓ Launch online resources and policy section of the website – Spring 2023.



## Modernize Peer Assessment

### TRANSPARENT, ACCOUNTABLE PEER ASSESSMENT PROCESS

- **Conduct evaluation and review of peer assessment process to enhance transparency and fairness.**
  - ✓ Initiate third party fairness review of assessment processes – August 2022.
  - ✓ Third party evaluation of peer assessment process complete, finding process to be transparent and fair, and providing opportunities for continuous improvement – December 2022.
  - ✓ Ongoing monitoring of assessment processes and improvement implementation – Fall 2023.
  - Develop fairness review monitoring framework – Spring 2024.
- **Introduce revised peer assessment framework.**
  - ✓ Revise assessment and ranking process to be introduced for 2022/23 programs – October 2022.
  - ✓ Implement recommendations from fairness review – ONGOING
- **Introduce designated priority groups to address gaps and support transparency.**
  - ✓ Introduce designated priority groups policy and web page – April 2022.
  - ✓ Implement designated priority groups policy in funding allocations – November 2022.



## Rebalance Funding Distribution

### FUNDING REDISTRIBUTION WITHIN EXISTING BUDGET TO SUPPORT EQUITY

- **Launch revised Operating Assistance program with single deadline for all professional organizations.**
  - ✓ Shift all Professional Operating Assistance to one intake deadline for 2022/23 – June 2022.
  - ✓ Revise funding allocation process to incorporate Designated Priority Groups – October 2022.
  - ✓ Revise assessment criteria groupings and weightings to include assessment of Reconciliation, Equity, Diversity, Inclusion and Access (30%); Artistic and Cultural Contribution, Engagement and Impact (40%); and Organizational Capacity and Governance (30%) – June 2022.
- **Reduce barriers in eligibility.**
  - ✓ Reduce timeframe requirement for how long an organization had been registered as a non-profit society and offered arts and culture programming to one year across programs – June 2022.
  - ✓ Reduce requirement for past BC Arts Council funding as part of eligibility for Operating Assistance from two discipline-specific grants to one Project Assistance grant and list of programs that could provide a pathway to Operating Assistance expanded to include Arts Based Community Development and Arts Impact – June 2022.
- **Focus on equity and transparency in processes.**
  - ✓ Update assessment criteria related to Reconciliation, Equity, Diversity, Inclusion and Access across programs – June 2022.
  - ✓ Revise Fair Notice Policy for Operating Assistance programs to include equity-based criteria – September 2022.
- **Highlight outcome and impact across funding programs, including pandemic recovery and renewal.**
  - ✓ Deliver one-time provincial pandemic recovery funding – March/April 2022.



- ✓ Implement new voluntary and required data collection mechanisms to support Designated Priority Groups policy, program evaluation and GBA+ Analysis – October 2022.
- ✓ Allocate funding and grant amounts to align with overall budget distribution – Winter 2023.
- Develop benchmarks based on evaluation of New Foundations, equity policy framework consultancy and new data collection mechanisms – Winter 2023 -UNDERWAY.
- ✓ Continue to redistribute funding and resources across programs and operations to meet Extending Foundations priorities – ONGOING.



## Deliver Arts Impact Grants

### FLEXIBLE STRATEGIC DEVELOPMENT PROGRAM

- **Offer continued support for pandemic recovery and renewal.**
- **Focus on outcomes and impact.**

#### **Program introduced 2021/22.**

- *Arts Impact Grants allowed applicants to define the most meaningful impact to their organization, practice, and/or community during recovery, renewal, and change.*
- *A total of \$8.03M was distributed through 310 grants across three components:*  
*Artistic/Cultural Practice*  
*Community and Sector Impact*  
*Organizations/Collectives*
- *Over 50% of recipients self-identified as being led by or serving Indigenous or equity-deserving communities and/or located in a regional area.*

- **Evaluate program and renew for future years.**

- ✓ Relaunch Arts Impact Grants for 2022/23, integrating feedback from the 2021/22 program and roundtables – October 2022.
- ☐ Relaunch next round of Arts Impact Grant – Winter 2023/24.



## Expand Arts Infrastructure Program

### SPACES THAT SUPPORT THE WORK OF B.C.'S ARTS AND CULTURAL PRACTITIONERS

- **Increase budget to support larger grant amounts.**
- **Expand eligibility of applicants and activity.**

#### **Program expanded 2021/22.**

- *The \$4 million BC Arts Council Arts Infrastructure Program develops and enhances arts and cultural spaces in B.C. The second year of the program launched November 12<sup>th</sup> 2021 and closed January 14<sup>th</sup> 2022.*
- *The base program budget increased by \$2M*
  - *Introduced new program stream to support planning projects (\$25K max.)*
  - *Expanded Capital Improvements maximum grant to \$250K.*
  - *Specialized Equipment stream (\$40K max.)*
- *Total dollars were distributed through 84 grants*
- *50% of recipients self-identified as being led by or serving equity-deserving organizations and/or from rural and/or remote communities.*

- **Evaluate program and renew for future years.**

- ✓ Relaunch Arts Infrastructure Program for 2022/23, integrating feedback from the 2021/22 program and roundtables – October 2022.
- ✓ Align further with Clean BC and greening of the arts initiatives – October 2022/ONGOING.
- ✓ Deliver an additional \$4.525 million through the Arts Infrastructure Program in 2022/23 – March 2023.

- Work with local, provincial, and national community partners to explore innovative and generative approaches to cultural infrastructure - ONGOING
