

Early Career Development: Basic Training Program—Internship and Cohort FOR ORGANIZATIONS in Regional Communities Program Guidelines 2026/27

Grant Program Summary

Grant program purpose: To support immersive and high-impact opportunities for Emerging and Early Arts Practitioners to develop their artistic or administrative practice, participate in learning opportunities and knowledge transfer, and expand their career experience.

Maximum grant amount: \$30,000

Applications – Open: May 27 | **Close:** July 8 | **Results expected:** November 2026

New applicants must register by: Thursday, July 2

Next intake: Spring 2027 (subject to change). You can find the [Grant Program Calendar](#) on the Funding section of our website.

Who can apply: Arts Organizations, Indigenous Governments, Indigenous Community Organizations, Indigenous Cultural Centres, Museums, and Book and Arts Periodical Publishers in [regional communities](#) in B.C. outside of [greater Vancouver or the capital region](#). See details in [Who can apply](#) section below.

New applicants: You must register in the online system to access the application. Registration requests must be received at least one week before the application closing date. Before you register or begin your application, you are encouraged to talk with a Program Advisor and make sure **you are eligible** and **your proposed project is eligible**. Ineligible applications will not be forwarded for assessment.

About Early Career Development

Early Career Development supports immersive and high-impact learning opportunities for Early Arts Practitioners (EAP) to:

- Develop their artistic or administrative practice.
- Participate in knowledge transfer, skill sharing, and reciprocal learning in the sector.
- Expand their career experience, professional networks, and exposure.

This program does not support the creation or development of new artistic projects.

Arts and culture organizations and individual Early Arts Practitioners can apply to this program through six components:

For Arts and Culture Organizations – Basic Training (use these Guidelines):

Only Arts and Culture Organizations in regional communities can apply to the Basic Training component.

Basic Training - Internship component supports arts and culture organizations in regional communities to provide paid, foundational, on-the-job training and experiential learning for new and emerging arts practitioners who want to work in their home communities.

Basic Training - Cohort component supports arts and culture organizations in regional communities to provide paid, foundational, on-the-job training and experiential learning for a group of two or more new and emerging arts practitioners who want to work in their home communities.

For the purposes of BC Arts Council grants and funding priorities, **regional communities are those outside of the Capital Region and Greater Vancouver**. Greater Vancouver includes the municipalities of the [Metro Vancouver Regional District](#). The Capital Region includes the municipalities of the [Capital Regional District](#). Bowen Island, Sooke, Metchosin, the Gulf Islands, and the Juan de Fuca electoral area are considered regional communities for this purpose.

The **Basic Training** component supports emerging and early career arts and culture practitioners who may not have access to training opportunities (for example, post-secondary studies) because of where they are located. We developed this component in response to needs identified through sector-wide consultations, in conversations with artists and arts organizations in regional areas, and through a review of results from recent program intakes.

The program will support mentorship and on-the-job learning that will enable eligible Early Arts Practitioners to work in their community, launch their professional practice, and support a regional arts and culture organization. This component will help arts organizations in regional areas to

support and develop a new *and local* generation of arts and culture workers and build capacity, sustainability, and opportunities to address succession.

This will be accomplished through:

- Connecting emerging artists living in regional communities with local arts organizations.
- Increasing access to the Early Career Development program (and other programs for individual artists) by offering support for basic training outside of institutional learning (which is supported through the BC Arts Council's Scholarship program).
- Supporting eligible organizations to build capacity through investing in community members.

For all Arts and Culture Organizations (regardless of location) (See [Guidelines for Organizations](#)):

Internship component supports arts and culture organizations to host a paid, learning-focused internship for an Early Arts Practitioner who has completed their basic training and is transitioning into professional practice.

Cohort component supports arts and culture organizations to host paid, learning-focused positions for a group or cohort of Early Arts Practitioners who are transitioning into professional practice.

For Individual Early Arts Practitioners (see [Guidelines for Individuals](#)):

Residency component supports Early Arts Practitioners who have completed their basic training and are transitioning into professional practice to complete a learning-focused residency with an arts and culture organization.

Mentorship component supports Early Arts Practitioners who have completed their basic training and are transitioning into professional practice to engage in one-on-one learning and knowledge transfer with an established practitioner in their art form or field of practice.

Grant amounts

Maximum grant amount is \$30,000.

You may request a grant for up to **100%** of the total eligible project expenses.

Submit a realistic and balanced budget that shows how much money you need to carry out the learning activities. BC Arts Council intends to support successful applications at 100% of their request. However, in some cases, grants may be awarded for less than requested.

BC Arts Council grant programs are competitive. We are not able to support all eligible applications. We generally fund between 20% to 30% of eligible applications in a program intake. An Early Arts Practitioner can only be named in one application per intake, regardless of component.

An organization can only submit one application per intake.

If a previous application for the same project was unsuccessful, we recommend that you request feedback from the Program Advisor and address the concerns in your new application.

Who can apply

Before you begin your application, make sure **you are eligible** and **your proposed activities are eligible**. Ineligible applications will not be forwarded for assessment. If you have questions about eligibility, contact a Program Advisor.

Eligible organizations

To be eligible, an organization must be:

- Located outside [greater Vancouver or the capital region](#).
 - A **professional arts organization** or a **community arts organization** registered and in good standing as a non-profit society or community service co-op in B.C. for at least one fiscal year prior to application with:
 - The majority of key staff and board members based in B.C.
 - Creative control and decision making for programming and engagement primarily maintained within the organization and by leadership based in B.C.
 - A purpose or mandate primarily dedicated to arts and culture programming and activities.
- or**
- A purpose or mandate to provide services to the arts and culture sector in B.C.
 - Operations and activities that reflect this dedicated purpose or mandate.

OR

- An **Indigenous (First Nations, Métis, Inuit) community organization** registered and in good standing as a non-profit society or community service co-op in B.C. for at least one fiscal year prior to application with:
 - The majority of key staff (paid or volunteer) and board members based in B.C.
 - A commitment to offering regular arts and culture activities.

OR

- An **Indigenous (First Nations, Métis, Inuit) government** in B.C. that offers regular arts and culture activities.

OR

- An **arts organization** operated by a local government in B.C. for at least one fiscal year prior to application, that:
 - Maintains an ongoing arm's length, community-based board of management or advisory structure that sets policy for the organization's programs and services.
 - Holds a dedicated programming space and has at least one dedicated staff person in an artistic, curatorial, editorial, or administrative leadership position who is responsible for programming and engagement.
 - Offers ongoing public programming by experienced arts and culture practitioners.

- Primarily operates with autonomy, holding creative control and decision making for programming and engagement within the organization, with separate financial records for operations. See Financial Statement Requirements section below for more detail.

OR

- An **arts organization** operated by a public post-secondary institution in B.C. for at least one fiscal year prior to application, that:
 - Holds a dedicated programming space and has at least one dedicated staff person in an artistic, curatorial, editorial, or administrative leadership position who is responsible for programming and engagement.
 - Offers ongoing public programming by experienced arts and culture practitioners, the majority of which is not programming of faculty or student works.
 - Primarily operates with autonomy, outside of curriculum, holding creative control and decision making for programming and engagement within the organization, with separate financial records for operations. See Financial Statement section below for more detail.

OR

- An **eligible book publisher** according to the criteria in the guidelines of the [Project Assistance: Literary Arts](#) or [Operating Assistance: Book Publishers programs](#).

OR

- An **eligible Indigenous Cultural Centre or museum** according to the criteria in the guidelines of the [Project Assistance: Museums and Indigenous Cultural Centres](#) or [Operating Assistance: Museums and Indigenous Cultural Centres](#) programs.

An eligible organization must also:

- Provide public arts and culture programming (or service to the arts and culture sector) in B.C. as a primary activity and have done so for a minimum of one year before the application closing date.
- Engage skilled artistic, curatorial, editorial and/or administrative leadership (volunteer or paid) for project or service delivery.
- Provide programs or publications that benefit or are of interest to the community at-large and not solely the interests of its nonprofit society members.
- Fairly compensate artists, arts and culture practitioners, technicians, Elders, and Knowledge Keepers. Compensation must align with project contexts and industry standards within the field of practice.
- Follow international intellectual property rights standards and cultural ownership protocols.
- Follow the [Criminal Records Review Act](#) which requires that people who work with or may have unsupervised access to children or vulnerable adults must undergo a criminal record check by the [Criminal Records Review Program](#).
- Not have any overdue final reports on previous BC Arts Council grants.

Ineligible organizations

The following types of organizations are not eligible to apply for this grant:

- Private or for-profit entities (except in the case of for-profit book publishing companies)
- Member-funded societies
- Social service organizations
- Industrial sites, archaeological sites, heritage sites, or historic places
- Organizations dedicated to archives
- Non-profit societies registered for less than one fiscal year
- Arts or Curatorial Collectives. Collectives hoping to work with an Early Arts Practitioner should encourage the individual artist to apply through the [Mentorship or Residency component](#).

Eligible Early Arts Practitioners

To be eligible to participate in a Basic Training project with an organization, an Early Arts Practitioner must:

- Live in the applicant organization's region and not have to relocate to participate.
- Be at least 18 years of age as of December 31, 2026.
- Not have had any basic training (for example, post-secondary arts education) or not have had more than two years experience working in the arts and culture sector.
- Demonstrate a commitment to the arts sector and their own creative practice through education or experience. Examples might include high school classes, community arts involvement, volunteer work, artistic achievements, or awards.
- Demonstrate the support of recognized local arts and culture practitioners and community leaders.
- Be interested in or actively pursuing a career or practice in one or more of the fields of practice funded by the BC Arts Council, including but not limited to:
 - Arts administration
 - Community-based arts
 - D/deaf, Disability and Mad arts
 - Indigenous Arts (beadwork, carving, drawing, jewellery, painting, textile or fibre arts, weaving, wearable art, including regalia)
 - Literary arts (creative writing, publishing)
 - Media arts
 - Multi- and interdisciplinary arts
 - Museums or Indigenous culture centres
 - Performing arts (music, theatre, dance, circus arts, comedy, production or technical)
 - Visual arts (critic, curator, artist in contemporary or traditional visual arts or craft)

- Be legally allowed to work in Canada as a Canadian citizen or a Permanent Resident.
- Be a B.C. resident who ordinarily reside in B.C. and has lived in B.C. for at least 12 continuous months immediately prior to the application closing date. For more information, review our [Determining B.C. Residency](#) page. You must be prepared to provide documentation to support residency status (if requested).
- Not be enrolled in full-time studies when the project is taking place.
- Not have participated in two previously successful Early Career Development applications regardless of component. In other words, an individual may participate in a maximum of two Early Career Development projects in their lifetime.
- Not be a participant in any other application in this program's current intake regardless of component.
- Not have any overdue final reports on previous BC Arts Council grants.

An Early Arts Practitioner cannot participate in an ECD project in the same fiscal year (April 1-March 31) that they receive a BC Arts Council Individual Arts Grant.

What you can apply for

We encourage you to contact a Program Advisor to discuss the eligibility of your project.

General eligibility considerations for a Basic Training Internship or Cohort

- Activities must prioritize high-quality learning, knowledge transfer, and skill development, and include specific learning objectives with tangible outcomes that will have a significant impact for the Early Arts Practitioner.
- Activities may include a combination of learning and creation. However, learning must be the primary focus with significant opportunities for skills sharing and knowledge exchange with artistic peers, mentors, or community members. The creation, development, and revision of new work cannot be the sole or primary objective.
- Activities must take place over a minimum of eight weeks to a maximum of one year.
- Activities must take place in organizations located **in areas outside [greater Vancouver or the Capital Region](#)**.
- Organizations must designate a qualified mentor within the organization. You can have more than one mentor or identify a main mentor within the organization and other sources of expertise from outside the organization. However, a series of unrelated mentorship activities is not eligible. You must clearly describe how different mentors contribute to a cohesive project.
- If the proposed intern or a cohort member is a recent or current employee of the organization, you must clearly indicate how the activities are new or supplemental to the previous or current work, and how the project is providing a meaningful learning experience. **This grant cannot be used to support an ongoing staff position.**
- You must follow intellectual property rights standards and cultural ownership protocols.

An eligible Basic Training Internship and Cohort application must:

- Identify an eligible Early Arts Practitioner(s) who will be engaged as a paid employee (either on salary or with a formal contract) in an immersive and structured experience. Part- and full-time placements are eligible.
- Outline employment terms, including pay level and status (for example, salaried and on payroll with deductions or on contract), benefits, hours of work, and length of employment. These terms must be confirmed and agreed to by the proposed intern.

Eligible Basic Training Cohort applications must:

- Engage all cohort members for the full duration of the project.
- Provide paid, learning-focussed opportunities to a group of at least two eligible Early Arts Practitioners who must be identified in the application, and who will work together in an immersive, cohesive, and structured experience. While they must be engaged in the same project, activities for individual participants may vary to allow for skill-building or knowledge-transfer opportunities aligned with the learning goals and career objectives of each participant.

Organizations applying for a Cohort should consult a Program Advisor to ensure the eligibility of the project.

Examples of eligible Basic Training Internship or Cohort activities**Examples of eligible Basic Training Internships or Cohorts include but are not limited to:**

- An aspiring stage actor in Fort St. John has participated in high school productions and volunteered as an usher at their local theatre company. The company hires them as an Arts Trainee for one year to participate in all aspects of mounting a season of plays. They will mentor with the Artistic Director with additional mentorship opportunities with the Stage Manager and a local dramaturg.
- A Nuu-chah-nulth carver has worked on numerous small carving projects, learning her technique from YouTube videos, and watching her father, a Master Carver. An Indigenous carving festival in Tofino hires her to train with the festival's Creative Director to learn about organizing and producing an arts festival. Additional training opportunities will be offered by an Indigenous carver on the Board of Directors and the festival's Executive Director.
- Three recent high school graduates living in Nelson, Winlaw, and Trail are hired by a regional museum as a Basic Training cohort to receive basic training from the curator in exhibit development.

Examples of Basic Training Internships or Cohorts that are *not* eligible include but are not limited to:

- An emerging actor in Powell River is hired by a local theatre company to help produce a new season of shows for the community without any training or mentorship from staff.
- Three emerging media artists living in Prince George are invited to work as a cohort at the public gallery: one will curate a new exhibit, one will work with the marketing director to develop their social media presence, and the third will write and produce catalogues for the upcoming exhibitions.

- An emerging arts administrator has been working for the past two years with the public gallery in their rural town and applies with the gallery for basic training funding to support their continued work.

Eligible expenses

The priority for this program is to support the salary or compensation for the Early Arts Practitioner(s). Appropriate compensation is fundamental to all components of this program. We recommend that applicants consider Living Wage requirements in their location as well as standards for their organization and field of practice. See **Resources** below.

Eligible expenses include:

- Salary or compensation for the Early Arts Practitioner(s).
- Mandatory employment related costs and related employment benefits for the Early Arts Practitioner(s).
- Travel and accommodation costs associated with the temporary relocation of the Early Arts Practitioner(s).
- Supplies, materials, and other reasonable costs directly related to your eligible activities.
- Equipment directly related to the project (up to \$2,500 maximum).
- Compensation for a mentor(s). Compensation paid to a mentor already working within an organization is only eligible if the hours are supplemental or not part of regular working hours. Funding is not intended to subsidize an organization's existing operating or salary expenses, but rather to support additional costs associated with the Internship or Cohort.

Required artist payment in project activities

Eligible projects must include appropriate payment to the Early Arts Practitioner, artists, arts and culture practitioners, and other arts and culture workers engaged in the proposed activities. Payments to artists should be consistent with recommended rates set by relevant arts service organizations, professional associations, or established practitioners within the field of practice.

Required payment to Elders and Knowledge Keepers in project activities

Applicants should pay Elders and Knowledge Keepers according to community context and appropriate protocols.

Exclusions - What will not be funded

Grants are not available to support the following expenses:

- General operating expenses.
- Budget deficits or surpluses.
- Contingency funds.
- Loan repayments.
- Start-up costs or seed money.
- [Capital expenses](#) (for example, construction, renovation, purchase of property).
- Equipment purchases over \$2,500 and any equipment purchases not directly related to the project.
- Activity or programming costs and other expenses that would be incurred whether or not the Early Career Development application is successful.
- Unpaid work placements.
- Subsistence for artists or culture practitioners.
- Costs of producing commercial recordings or demo reels.
- Touring or travel expenses not directly associated with the proposed activity.

Grants are not available to support the following activities:

- Creation, development, or preparation of work, including for performance, audition, and exhibition.
- Project phases or activities that begin before the application closing date.
- Feasibility studies.
- Activities that are not based upon artistic, editorial, or curatorial decision making, or where arts and culture is not the primary focus.
- Activities that require payment from artists to participate without additional and adequate compensation, for example: art and craft fairs, conferences, and conventions.
- Fundraising activities.
- Conferences and conventions.
- Family, religious, anniversary, or community celebrations.
- Contests and competitions, except if competition is integral to the art form or cultural practice, for example: hip-hop and street dance, poetry slams, powwows.
- Podcasts and radio programming that are not embedded within an established artistic practice or specifically dedicated to the dissemination of artistic works.
- Activities where art therapy, health or therapeutic work is the primary focus.

- Vocational placements required as part of basic training or accreditation (formal apprenticeship, practicum, co-op programs).
- Curriculum-based activities or projects including those related to continuing education or post-secondary programs at educational institutions.
- Training to support teaching of non-professional artists. For example, teaching community-based programs or teaching children.
- Activities primarily intended for or focused within creative industries or the commercial sector (with the exception of book publishers), including film and television for theatrical release or prime-time broadcast, voice-over work or acting for camera, music production for film or TV, animation, video game design and development, mass media, journalism, podcasts, screenwriting, graphic design, industrial design, interior design, commercial fashion design, commercial dance, culinary arts, architecture, games, sports, recreation.
- Project phases or activities previously funded through this grant program or other BC Arts Council grant programs.
- Activities previously funded with BC Arts Council funds delivered through third-party delivery partners: ArtStarts, First Peoples' Cultural Council, BC Live Performance Network, Creative BC.

When and how to apply

Application Intake – Open: May 27 | **Close:** July 8 | **Results expected:** November 2026

New applicants must register by: Thursday, July 2

Applications will be accepted until 11:59 p.m. (Pacific Time) on Wednesday, July 8, 2026.

An Early Arts Practitioner can only be named in one application per intake, regardless of component.

An organization can only submit one application per intake.

New applicants

- Closely review these guidelines to make sure your organization and proposed project are eligible.
- Register and create a profile in the BC Arts Council's online Grant Management System (GMS) to access the application. Instructions are on our website: [How to Apply Online](#).
- We recommend you register at least 2 weeks before the application closing date.
- New registrations go through a review. The review and approval process may take up to five business days after we have received all required documents. **Register early to avoid delays.**
- **Registration requests received within five business days of the application closing date will not be processed until after the grant program has closed.** You will not be able to submit an application if you are not registered.
- You will receive an automated email when your registration request is approved.

- Add the automated email address **NoReply@BCArtsCouncil.ca** to your safe senders list and check your spam folders.
- Once approved, you will be able to complete your Organization Profile and access the application.

Returning applicants

- Closely review these guidelines to make sure your organization or collective is eligible and proposed activities are eligible.
- Update your Organization Profile in the online system before starting the application.

Accessibility support

Organizations with a primary purpose to serve D/deaf or disability arts practices may be eligible for the BC Arts Council's accessibility programs.

Application Assistance pays for support services for creating and submitting grant applications.

Access Support provides additional funding for access costs related to a project funded by a BC Arts Council Grant.

What is needed for the application

You are responsible for submitting a complete application. You will not be contacted to address errors or missing elements. Eligible applications are assessed as submitted.

As part of our commitment to accessibility, the BC Arts Council is accepting parts of applications in audio and sign language formats. See instructions within the application.

All applicants: Update your online Organizational Profile including mailing address, Designated Priority Group, and Voluntary Self-Identification sections before submitting your application.

An **application checklist** is included at the end of these guidelines.

A complete application must include:

- Answers to questions in the application. Questions with a **red *** are mandatory and must be answered. The [Application Preview is a downloadable Word document](#) that can be used offline to prepare your responses.
- A statement describing the organization's history, mandate, mission, and core values.

- A general description of the project and main activities.
- A work plan that aligns with and supports the Early Arts Practitioner’s learning goals. Use a time period that is appropriate for your project. For example, for a one-year project, use monthly or bi-monthly periods; for a six-month project, you might use a combination of weekly and monthly periods.
- A resume or CV from the Early Arts Practitioner indicating training and education, awards, work experience (including volunteer work), exceptional opportunities or experiences significant achievements or contributions that relate to their practice and the application. Be sure to indicate locations and dates for all of the above. A sample resume and CV can be found on the Early Career Development Program webpage under **Resources**.
- A biographical statement prepared by each Early Arts Practitioner (up to 800 words each) responding to the points below. See the application for additional guidance on preparing this document:
 1. Briefly introduce yourself and your current artistic practice. Include any personal, social, or cultural identity details you are comfortable sharing and that are relevant to this project.
 2. Describe your artistic, learning, and career development goals as they relate to this project. What skills do you hope to develop? What knowledge do you want to acquire? Where do you hope to be in your practice in five years? Ten years? Be specific and provide examples.
 3. Discuss any challenges you face pursuing an artistic career or practice that relate specifically to your location.
 4. How will working with this specific organization and mentor have an impact on your practice and your career in the arts? What specifically will you learn? Refer to your goals as described above and discuss the impact on your long-term career aspirations.
 5. Confirm your agreement with the terms of engagement (length of project, hours of work, rate of pay) as described by the host organization.

Early Arts Practitioners should consider the following when preparing their statement:

- Assessors may not be familiar with their work, specific practice, community, or culture. Provide the information they need to understand the project: define technical terms or processes and avoid specialized or academic language or expressions that may be difficult to understand. If specialized terms must be included, provide a brief definition.
- Use short, clear sentences or point form while still providing answers that fully respond to each question.
- Word counts indicate the maximum accepted words. You are not required to write to that limit.

You have the option of providing the biographical statement in one of three formats. You can provide a written document, an audio file, or a video file. See application for allowable formats.

You must also:

- Provide a balanced project budget. Include detailed notes and ensure the Amount Requested in the application matches the request amount in the Budget.
- Provide up to two signed letters from mentors confirming their participation in the project— one letter per mentor. (PDF, two pages maximum per letter). The letter must include a:

- Their experience that makes them qualified to provide training, mentorship, and knowledge transfer that responds directly to the Early Arts Practitioner’s learning goals.
- Confirmation of their capacity to participate in the project.
- Commitment to providing a physical and culturally safe work environment, describing their practices and values that support this.
- Statement about the potential reciprocal impacts of the project on the mentor and on their community of practice.
- Confirmation of the schedule and format of the mentorship
- Letters from partners or collaborators, if applicable, confirming the nature of their participation (Maximum two letters, one page each, PDF). These must not be general letters of support.

Excess support material, including multiple links to materials within a single uploaded document, will not be reviewed.

Online profile updates required from organizations

Before you apply, you must update your online organization profile with the following:

- **Contact information:** Mailing address and other leadership contact information.
- **Board member list:** The organization's current board of directors, editorial advisory board, trustees, or board of management, including their board position, occupation/expertise, start date, and place of residence.
- **Staff member list:** Administrative, artistic, and editorial staff and significant contractors, including name, position, place of residence, and employment status (for example, permanent or part-time).
- **Constitution or statement of purpose:** Required upload(s):
 - **For non-profit societies:** PDF copy of the organization’s certified constitution.
 - **For extraprovincial non-share corporations:** PDF copies of the organization's official Certificate of Incorporation under the Canada Not-for-profit Corporations Act, Form 4001 Articles of Incorporation, and bylaws.
 - **For community service cooperative associations:** PDF copy of the organization's certified Memorandum of Association and Rules.
 - **For all other applicants:** Statement of the primary purpose of the organization.
- Completed **Designated Priority Groups** information section (required for funding prioritization).
- Answers in the **Equity Data Tool** that are relevant to your organization (required for funding prioritization). You are not required to answer every question.
- **Financial statements:** Upload signed financial statements for your two most recent completed fiscal years. See details below.

Financial statement requirements

All organizations (except collectives) must upload to their online profile signed financial statements for their two most recent completed fiscal years.

Following standard accounting formatting, financial statements should include comparative information for the prior fiscal year. If a comparative year is not included within a single set of statements, a set of financial statements for each year must be uploaded. Balance sheets or ledgers alone are not considered complete financial statements.

RESOURCE: Samples of a Balance Sheet and Revenue and Expense Statement (Income Statement) are available through [Community Gaming Grants application resources](#), under Example Documents.

Not-for-profit organization financial statements, including those internally prepared, must include:

- A balance sheet, income statement, and notes following standard accounting formatting.
- An itemized list of grants identified by funder, included either in the income statement or in an attached schedule.
- A breakdown of operating net assets, distinguishing between unrestricted net and capital assets.
- Signatures of the preparer and **two** board members affirming board approval.

For applicants operating under the umbrella of a local government, an Indigenous government, or a post-secondary institution, financial statements must include:

- A statement of income and expenses for the applicant's activities alone.
- A signature of the umbrella organization's financial officer.
- Notes indicating if the applicant entity may accrue assets, surpluses, or deficits from one year to the next.
- An itemized list of grants received that are related to the applicant, not the entire umbrella organization, and identified by funder, either in the income statement or attached schedule.

The type of financial statements required is based on the single largest BC Arts Council grant received in the organization's previous two fiscal years, not including Arts Impact grants, Accelerate grants or Arts Infrastructure Program grants. Refer to the chart below.

If you did not receive an applicable grant in the previous two fiscal years, internally prepared financial statements are acceptable. The statements must include all information listed above.

BC Arts Council reserves the right to request audited financial statements, regardless of the amount of the applicant's previous funding.

\$0 to \$15,000	Internally prepared financial statements
\$15,001 - \$40,000	Independently prepared financial statements: Notice to Reader/Compilation Engagement Report

How funding decisions are made

Peer assessment

The following process is used to evaluate every application to this grant program:

- The BC Arts Council reviews each application for eligibility.
- Eligible applications are forwarded to an independent peer assessment panel. Assessment panels include individuals (assessors) with broad artistic knowledge, experience, geographical representation, and diverse aesthetic, institutional, and cultural viewpoints, including those from Indigenous perspectives.
- Assessors read and score the applications using the assessment criteria below.
- The assessment panel discusses, then ranks the applications. Grants are awarded based on this ranking.
- Funding priority may be given to applicants considered part of a [designated priority group](#).
- The BC Arts Council informs each applicant of the peer assessment panel's decision approximately 16 weeks after the application closing date.

Applicants may check the status of their application at any time through the online system.

All results are final.

Assessment criteria

The assessment panel will read and evaluate your application based on the following criteria.

Each criteria category is assigned a percentage of your application's total score (out of 100). For example, a category weighted at 20% means you can score between 1 and 20 in that area. Compelling, detailed, and specific answers with strong evidence and clear alignment with the assessment criteria will score higher.

Keep these criteria in mind as you complete your application. Some of the specific points below may not apply to your project. However, your application should clearly explain how the proposed project generally meets each area of assessment.

The [Scoring Guide](#), which will be used by the assessors as they review your application, will help you to understand and address the program priorities.

IMPACT ON THE EARLY ARTS PRACTITIONER (50%)

- Contribution to the Early Arts Practitioner's professional growth and artistic practice, professional network, and the next stage of their career.
- Depth of knowledge transfer and skill sharing.
- Urgency of the project relative to the Early Arts Practitioner's stated learning and career development goals.
- Early Arts Practitioner's experience and capacity to undertake the project.
- Experience and capacity of mentors and host organizations relative to the Early Arts Practitioner's learning goals and activities.

IMPACT ON THE ORGANIZATION, COMMUNITY, AND ARTS SECTOR (30%)

- Support or benefit to specific arts and culture practices, including in relation to identified needs in the sector.
- Contribution to the artistic practices of equity-deserving arts practitioners and communities, including communities located outside major urban centres.
- Ethical approaches to research, collaboration, ownership, protocols, and issues of cultural appropriation.
- Respectful engagement with Indigenous peoples, communities, practices, materials, and beliefs.
- Impact on the organization and mentor(s), and opportunities for reciprocal learning.

APPLICANT READINESS (20%)

- A realistic workplan that supports the learning outcomes
- A reasonable plan for using the money.
- Plans and processes that confirm a safe, respectful, and equitable work environment including fair compensation and accessibility considerations including support for those who experience barriers or disability

Designated Priority Groups

The BC Arts Council is committed to targeted investment in underserved and equity-deserving organizations. These [designated priority groups](#) are the focus of strategic measures, dedicated programs, funding prioritization processes, and other equity support initiatives.

Designated priority groups include applicants and arts and culture practitioners who are:

- Indigenous (First Nations, Métis, or Inuit) Peoples
- Deaf or experience disability
- Black or people of colour
- Located in areas outside [greater Vancouver or the capital region](#)

If the majority of your activities, programming, and resources are dedicated to one of the groups listed above, and if your organization or collective would like to be considered for equity support measures including priority funding, you must complete the Designated Priority Groups and Equity Data Tool sections in your online Organization Profile.

Notification of results and feedback

The BC Arts Council intends to inform applicants of the assessment results approximately **16 weeks** after the application closing date.

Notification is sent by email to the primary contact linked to the application. Emails are sent through the online system. Be sure the email address **NoReply@BCArtsCouncil.ca** is on your safe sender list.

Results will not be shared before official notification emails are sent.

Feedback

Contact a Program Advisor for feedback on your application after you have received notification of the results.

Payment of grants and reporting requirements

Grant payments are subject to an authorizing appropriation under the *Financial Administration Act*.

The BC Arts Council reserves the right to redistribute, delay, or suspend payments if the recipient:

- Does not carry out its planned program of activities.
- Makes major changes in artistic or administrative direction.
- Does not meet its obligations as a grant recipient, including submission of final reports.
- Fails to comply with legal obligations.
- Fails to respect the commitment to provide a safe and respectful workplace free from harassment, discrimination, and sexual misconduct.

Grants will be paid by cheque and sent to the mailing address listed in the individual or organization profile in the online system unless the applicant is registered for [direct deposit](#).

Grants are taxable income and must be reported. Individuals receiving grants on their own behalf or on behalf of a collective are issued T4As for the year the grant payment is processed.

Final reports

Grant recipients must submit a final report for the completed project. Final reports must be submitted through the online system within 30 days of the project end date noted in the application.

You will not be able to submit future applications to the BC Arts Council if you have an overdue final report. If at any time, there are significant changes to your approved project or timeline, contact the program advisor associated with the program.

Recognition of grants

In recognition of grant funding, BC Arts Council and the Province of British Columbia's support should be acknowledged in all promotional materials, both print and online. The approved BC Arts Council and Province of British Columbia logos and guidelines for use are available [online](#).

Grant recipients with a website are encouraged to add a link to the [BC Arts Council](#) website.

Confidentiality of information

The collection, use, and disclosure of personal information are subject to the privacy provisions of the Freedom of Information and Protection of Privacy Act. The applicant's information will be shared in confidence with members of the assessment panel. The names and locations of successful grant recipients may be published, along with the amount of the grant, in the BC Arts Council's Annual Report as well as in various communications and promotional vehicles of the BC Arts Council and Province of British Columbia. Social Insurance Numbers are provided to Canada Revenue Agency through the issuance of T4As.

Be sure you have included or completed the following before you submit your application.

Before you apply:

- ❑ Plan to submit your complete application at least two days before the deadline to avoid last-minute issues.
- ❑ **New BC Arts Council clients:** [Register in the BC Arts Council online system to gain access to the online application](#). We recommend you register at least two weeks before the application closing date.
- ❑ **All BC Arts Council clients:** Complete all required updates to your Organizational profile:
 - ❑ Update your mailing address and other contact information.
 - ❑ Upload your most recent signed financial statements. See Financial Statements Requirements section of guidelines.
 - ❑ Update your Board list and Staff list.
 - ❑ Upload your organization's certified constitution (for not-for-profits) or statement of purpose (for all other organizations). Do not include by-laws.
 - ❑ Complete the Designated Priority Group section (required for funding prioritization).
 - ❑ Complete the Equity Data Tool (required for funding prioritization).
 - ❑ Ensure you have completed and submitted any overdue final reports for previous BC Arts Council grants. An overdue final report will block your application from being submitted.
 - ❑ Review the Program Guidelines and Application Preview on the [BC Arts Council website](#) for specific requirements for this program.

In your application:

- ❑ Read and respond to all information in the grey text boxes on the online application.
- ❑ Ensure your Project Start Date is after the intake closing; include a realistic Project End Date.
- ❑ Complete each section and answer all questions that are applicable to your project. Questions with the **red *** are mandatory. Be sure your responses indicate your project's alignment with the program's intentions and the assessment criteria. Refer to the [Scoring Guide](#) for support.

Budget:

- ❑ Review the preamble at the top of the pop-out budget form.
- ❑ Include all expenses and revenues for activities described in the application.
- ❑ Include detailed notes for each expense.
- ❑ Be clear which expenses are covered by the request to this program.
- ❑ Ensure any ineligible expenses are covered by other revenue sources.
- ❑ Indicate whether revenues are confirmed or pending.
- ❑ Be sure your budget is balanced, and balance in-kind revenues with in-kind expenses.
- ❑ Make sure Amount Requested in the application matches the requested amount in the Budget.

Material to upload and review:

- ❑ A CV or resume from the Early Arts Practitioner (PDF, maximum 3 pages). Refer to the sample CV on the [BC Arts Council website](#) for guidance.
- ❑ A statement from the Early Arts Practitioner responding to the questions in the application (PDF, maximum 800 words).
- ❑ Letters from Mentors confirming their qualifications, capacity, and the nature of their participation (PDF, maximum two letters, one page each).
- ❑ A workplan that outlines how you will spend your time throughout the project. Refer to the sample workplan on the [BC Arts Council website](#) for guidance.
- ❑ Make sure your uploaded material is in the correct format per directions in the guidelines.
- ❑ Ensure you have not submitted material beyond what is requested.

Before you submit your application:

- ❑ Review and proofread your application for clarity, omissions, errors, etc. Use the [Scoring Guide](#) for support when reviewing your application.
- ❑ Ask a friend or trusted colleague to review the application for clarity, omissions, errors, etc.

And then:

- ❑ Complete the Access Support tab (as applicable).
- ❑ Share your feedback in the Feedback tab (optional).
- ❑ Read the Declaration tab and complete the acknowledgement.

After you submit your application:

- ❑ Be sure that NoReply@BCArtsCouncil.ca is included in your safe senders list. Notification of results will come from this system email roughly 16 weeks after the intake closing date.
- ❑ Keep your mailing address up to date in your online Organization Profile. Grant payments will be mailed to this address (unless you have registered for Direct Deposit).
